DATCP Likely to Review Livestock Facility Siting Rule (ATCP 51)

The Department of Agriculture, Trade and Consumer Protection (DATCP) has published a Scope Statement indicating their desire to promulgate amendments to Wisconsin's Livestock Facility Siting Rule. The Scope must be approved by the DATCP Board before DATCP can move forward with rule promulgation.

The Scope Statement indicates that DATCP initiated this first statutorily required 4-year review of the siting law in 2010. The Department has received over 860 comments at the public listening sessions regarding the siting law. The Scope Statement indicates that the DATCP anticipates spending 18 months drafting the rule. The rule revisions will consider the recommendations of the technical expert committee that was appointed earlier this year to review the standards.

Treatment of Threatened Bat Species May Affect Forestry Activities

The Department of Natural Resources has requested that four species of cave bats be added to Wisconsin's threatened species list. The Department indicated to the Natural Resources Board at their September meeting that the addition of these four bat species was necessary to begin to combat the decline in the bat populations nationally and to address the "immediate threat of white-nose syndrome" in Wisconsin. According to the Department, white-nose syndrome is a disease that has been linked to the death of "over one-million bats since 2007 and threatens to cause the extinction of several bat species in the near future."

If these four new species are added, the DNR will revise their broad incidental take permit to address takings of these bats. Accordingly, the Department has proposed a revised incidental take permit, which allows for the incidental taking of bats as a result of certain activities. However, the proposed permit would restrict forestry activities within 1 km of a waterbody or wetland. The permit states that, "No snags or dying trees may be cut from June 1 – August 31" within 1 km of a waterbody or wetland. In addition, bats must be excluded from buildings in order for buildings with bats to be eligible to be demolished between June 1 – August 31. The Department is taking comments on the proposed incidental take permit until November 4, 2010. The Department is also taking public comments on the proposed rule adding the four bat species to the threatened list until November 29th. Reminder: Elections on November 2nd By Jordan Lamb -- DeWitt Ross & Stevens

Wisconsin's statewide elections will be held on Tuesday, November 2nd. Wisconsin has an open seat in our Governor's chair. Republican, Scott Walker, will face Democrat, Tom Barrett, in the general election. Walker is the current Milwaukee County Executive and Barrett is the current Mayor of Milwaukee making this race for governor an "all Milwaukee" race.

In the State Senate, 17 of the 33 seats are up for re-election in 2010. In the Wisconsin Assembly, all 99 seats are up. The Democrats currently control the State Senate by an 18-15 margin and also control the State Assembly by a margin of 51-46 (with two independents). That means that the balance of power shifts in the Senate if the Republicans take 2 seats. The Assembly could flip if the Republicans take 4 seats.
