Craig Carncross owns and operates Wargo Acres near Lodi, Wis. The 450 cow dairy strives to develop cows that last while producing high component, high quality milk. Wargo Acres is a 100% registered Holstein herd and operates about 500 acres. The name "Wargo" comes from his grandfather and father who formed a partnership in the 1970s. Craig joined the operation after college in 1999 and has farmed with his parents Gordon and Emily since; they have retired but are still involved.
